In the interest of providing full information and disclosure relating to professional liability options, and meeting the purpose of providing accessible information about providers of professional liability insurance for educators, the District discloses, in accordance with the Idaho Tort Claims Act (Idaho Code 6-901 et. seq.) a governmental entity is required to provide a defense to its employees, including a defense and indemnification against any claims brought against the employee, in the employee's individual capacity, when the claims are related to the course and scope of employment, and be responsible for the payment of any judgment on any claim or civil lawsuit against an employee for money damages arising out of an act or omission within the course and scope of employment. (Idaho Code 6-903).

The District procures liability insurance, on an annual basis, which does include coverage for all employees and volunteers working within the course and scope of employment for the District.
