HOMELESSNESS SECTION

My child...

My child...

- ☐ Has failed one of more academic subjects in the past year

- ☐ Is 2 or more semester credits/year behind the rate required to graduate or for grade promotion

- ☐ Has documented or pattern of substance abuse behavior
- ☐ Is pregnant or a parent
- ☐ Is an emancipated or unaccompanied youth
- ☐ Is a previous dropout
- ☐ Has serious personal, emotional, or medical issue(s)
- ☐ Has a court or agency referral
- ☐ Demonstrates behavior that is detrimental to their academic progress
